Direct holding ratio by foreigners

The foreign investors' holding ratio is ratio in between the total number of stocks held by the foreigners and total number of outstanding shares issued by the company.

Upper limit on foreign investment

The upper limit on foreign investment is the maximum investment level allowed by the government to the foreign person/company.


